### Mequon Campus

Students learn skills related to emergency medical services and fire protective services. Includes preparation for Firefighter I Certification & Hazmat Operations as well as the opportunity to earn the EMT Technical Diploma upon successful completion of the program.

#### About

Dual Enrollment Academy (DEA) participants receive college-level training to begin careers in high-demand fields. Throughout their senior year, DEA students earn high school and college credits while spending the majority of their school day at MATC. The DEA is designed for students attending high schools within MATC's district.

#### Student Eligibility Requirements

- Be a 2026-27 high school senior
- Have a counselor recommendation
- Have a high school GPA of 2.0 or higher
- Be in good academic standing and on track to graduate from high school
- Have 90% attendance record in high school (exceptions made for illness)

### Cost

### FIRE TECHNICIAN PATHWAY

#### Emergency Medical Technician

This program is designed to prepare students to enter the emergency services field. Completing the program with a grade of C or higher prepares you to take the National Registry Examination, required for certification and licensure in Wisconsin. **Technical Degree earned in DEA**

#### MATC Fire Protection Technician Associate Degree

This program prepares you for employment in the fire service and for fire-related duties within private industry. Students will have the opportunity to obtain three Wisconsin fire certifications. **REMAINING CREDITS: 44**
