### **General Evaluation**

A general evaluation is also called a 'Document by Document' evaluation and is used to verify that one has a degree from either a high school or a college/university. This evaluation names and describes all diplomas, certificates, degrees, and periods of education or training, and gives U.S. equivalencies for each.

### University and Post-Secondary Course-by-Course Evaluation

MATC's policy requires that all college and university transcripts be evaluated course by course. This evaluation gives course, grade, and credit equivalents in U.S. terms. It is required to transfer credits to MATC or to be considered for a waiver of the college's placement test.
